

BYLAW NO. 19/2018

A BYLAW OF THE TOWN OF REGINA BEACH TO PROVIDE A UNIFORM SYSTEM FOR THE NUMBERING OF HOUSES AND OTHER BUILDINGS

The Council of the Town of Regina Beach in the Province of Saskatchewan enacts as follows:

1. That a uniform system of numbering houses and other buildings, as shown on the attached maps attached hereto as Form A and which form part of this bylaw, shall be used in the Town of Regina Beach.
2. That all existing numbers of houses and other buildings not now conforming with the provisions of this bylaw shall be changed to conform to the system herein adopted.
3. Each house and/or building shall bear the number assigned to the frontage on which the building is situated. In case a house or building is occupied by more than one family dwelling unit or business, each separate entrance of said house or building shall be identified.
4. Numerals indicating the official number of each house or building shall be posted in a manner as to be visible from the street on which the property is located.
5. The Administrator of the Town of Regina Beach shall be responsible for maintaining the numbering system and shall keep a record of all numbers assigned under this bylaw.
6. (1) A person found guilty of an infraction of any provision of this bylaw shall be liable to:
\$50.00 for the first offence
\$75.00 for each subsequent offence (30 days after first offence)

(2) The Notice of Violation shall be in Form B attached to and forming part of this bylaw.
7. That Bylaws 6/89 and 4/2000 are repealed.
