BYLAW NO. 10/97

A BYLAW TO AMEND BYLAW NO. 3/96, A BYLAW RESPECTING BUILDINGS

The Council of the Town of Regina Beach, in the Province of Saskatchewan enacts as follows:

- 1. Bylaw No. 3/96 is amended by deleting clause 5(2) and by substituting the following:
 - 5(2) That a legal survey is required for all new construction and any major additions exceeding 50% of the original footprint of the building. An inspector may require submission of an up-to-date plan or survey prepared either before construction begins or upon completion of work by a registered land surveyor, as a condition of permit approval.
- 2. Bylaw No. 3/96 is amended by deleting clause 5(6) and by substituting the following:
 - 5(6) The permit fee for erection, placement, construction, alteration, repair renovation or reconstruction of a building shall be based on the following fee schedule.

1. RESIDENTIAL BUILDINGS

- a) Minimum Charge Principal Building \$400.00
 Additional Charge of \$2.20 per square meter
 for area of buildings over 139 square meters
 (THIS FEE COVERS UP TO 6 INSPECTIONS)
- b) Accessory Buildings \$ 75.00 Detached garages, tool sheds, gazebos etc.
 (THIS FEE COVERS 1 INSPECTION,
- c) Decks \$ 75.00 (THIS FEE COVERS 1 INSPECTION)
- d) Addition to dwellings & attached \$250.00 garages plus \$2.20 per square meter for area of addition over 75 square meters (THIS FEE COVERS UP TO 4 INSPECTIONS)
- e) Renovations (The number of Inspections that this fee will cover to be determined by Building Inspector upon plans provided from Owner or applicant for approval) \$175.00
- f) Extra or Re-inspection \$ 75.00/each
- 2. COMMERCIAL/INDUSTRIAL/INSTITUTIONAL BUILDINGS AND MULTI-FAMILY DWELLINGS
 - a) All buildings \$1.00 per square meter
 - b) Minimum Charge

- principal building \$500.00 - accessory building \$100.00 - additions \$300.00

plus \$1.00 per square meter for area of addition over 45 square meters

- renovations \$200.00

- extra or re-inspection each \$ 75.00/each

THE NUMBER OF INSPECTIONS COVERED UNDER THESE FEES MUST BE DETERMINED BY THE BUILDING INSPECTOR AT THE BEGINNING OF THE PROJECT.

- 3. BUILDINGS TO BE MOVED FROM WITHIN OR OUTSIDE THE.
 TOWN OF REGINA BEACH
 - a) Pre-move inspection \$150.00 plus \$75.00 per hour for travel time
 - b) Post-move (fees under Clause 1 or 2 above depending on the type of huilding shall apply).
- 3. Bylaw No. 3/96 is amended by deleting clause 5(8) and by substituting the following:
 - 5(8) All permits issued under this section expire one year from date of issue except that a permit may be renewed for six months upon written application at a cost of \$100.00. After eighteen months, a new building permit must be applied for.
