

**BYLAW NO 10/2015**

**A BYLAW OF THE TOWN OF REGINA BEACH TO  
APPOINT BYLAW ENFORCEMENT OFFICERS**

---

The Council of the Town of Regina Beach, in the Province of Saskatchewan enacts as follows:

1. The Council of the Town of Regina Beach hereby appoints the Bylaw Enforcement Officer employed by the Town of Regina Beach, Chief Administrative Officer, and the Public Works Manager, or their designates in their absence, as Bylaw Enforcement Officers for the Municipality.
2. The appointment shall commence at the signing of each applicable employment contract and shall continue at the pleasure of Council.
3. The appointment may be terminated by either the Council or the Bylaw Enforcement Officer with 30 days written notice.
4. The duties of the Bylaw Enforcement Officer shall be:
  - a) to enforce the municipal Bylaws set out in the attached Schedule;
  - b) to represent the Municipality before a justice of the peace or provincial court judge in the prosecution of anyone who is charged with contravention of a Bylaw;
  - c) and other duties as may be assigned by Council or its delegate.
5. Bylaw #3/2012 is hereby repealed.
6. This Bylaw shall come into force and take effect on the date of signing.
