

**BYLAW NO. 15/2019
TOWN OF REGINA BEACH**

**A BYLAW TO AMEND BYLAW 11/2019 A BYLAW TO CREATE BYLAW OFFENCES
AND TO PROVIDE PENALTIES FOR THEIR CONTRAVENTION**

That the Council of the Town of Regina Beach, in the Province of Saskatchewan, enacts as follows:

1. Section 7. Voluntary Payment Offences be amended to add:

(3) The voluntary payment amount for an offence designated as a Category 3 offence in Table 1:

(a) In the case of an individual:

- i. is \$150, in the case of a first offence;
- ii. is \$1000, in the case of a second offence;
- iii. is \$5000, in the case of a third or subsequent offence;

(b) in the case of a corporation:

- i. is \$250, in the case of a first offence;
- ii. is \$2000, in the case of a second offence;
- iii. is \$10000, in the case of a third or subsequent offence.

2. Table 1 is amended to add:
